REGULAR BUSINESS

Report – Strategic Plan – Chief Andrews reported on the progress each of the committees were making. Objective 1A: Obtain new data set to inform decision making - Demand for services has been identified geographically although response times on county roads isn't available from the County. Objective 1B: Establish a culture of accountability – The survey has closed and preliminary results have been received along with follow-up with more detailed results. Objective 5B: Chief Andrews has reached out to the International Association of Fire Chiefs and Washington Fire Chiefs in search of formal training for Labor/Management Leaders. IAFC hasn't responded and the WFC is working on a workshop in Fall 2023. Objective 3C: Maintenance has made significant progress implementing software to track maintenance costs. Objective 5C: Captain McKeen has developed a proposal for a main training facility and need for training props, etc. can be addressed once a decision is reached. A potential grant source for the facility is being investigated.

Agenda Bill 1: Q3-2022 Financial Statement - Finance Manager Whitaker summarized the District's Financial Statements as of September 30th, 2022 and answered questions.**NO ACTION: INFORMATION ONLY.**

Agenda Bill 2: Approval of Payroll and Expense Claims for Period Ending October 18th, 2022, Commissioners conducted their review of the expense claims and payroll reports. Commissioner Miano moved and Commissioner Nicholas seconded to approve Accounts Payable Claim check numbers 110694 through 110751, dated October 18th, 2022 totaling \$441,150.94; Payroll EFT's and IRS deposit Monthly Payroll Draw dated September 23rd, 2022, in the amount of \$23,902.64; Monthly Payroll EFT's and IRS Deposit dated October 7th, 2022, in the amount of \$638,018.63; for a disbursement grand total equaling \$1,103,072.21 . **MOTION CARRIED**.

Agenda Bill 3: 2023 Budget Workshop – Financial Manager Whitaker presented the 2023 Budget Draft including proposed 2023 Career Staff, the Budget Summary and Detail along with proposed 2023 Capital Purchases and Projects. With the use of FM Whitaker's interactive fiscal spreadsheet, Commissioners were able to plug in various budgeting scenarios and obtain the fiscal impacts up to seven years out (2029). Commissioners requested that Liz Loomis be invited to attend the next regular board meeting. **NO ACTION: INFORMATION ONLY.**
