## **REGULAR BUSINESS**

**Report** – **Strategic Plan** – Chief Andrews updated the Commissioners on the Strategic Plan and indicated that staff is making progress on numerous objectives.

Agenda Bill 1: Approval of Payroll and Expense Claims for Period Ending March 15<sup>th</sup>, 2022 Commissioners conducted their review of the expense claims and payroll reports. Commissioner Miano and Commissioner Nicholas seconded to approve Accounts Payable Claim check numbers 110265 through 110336, dated March 15<sup>th</sup>, 2022 totaling \$206,711.30; Payroll EFT's and IRS deposit for Monthly Payroll Draw dated February 25<sup>th</sup>, 2022, in the amount of \$25,627.29; Monthly Payroll EFT's and IRS Deposit dated March 10<sup>th</sup>, 2022, in the amount of \$636,421.91; for a disbursement grand total equaling \$868,760.50. **MOTION CARRIED**.

**Agenda Bill 2: General Levy CPI Inflator** – Financial Manager Alwynn, using spreadsheets and graphs, explained how the General Levy CPI Inflator affects the District's financial health. She complimented the Board of Commissioners for making tough decisions in the past that have provided the District with a strong foundation for moving forward with the growth necessary to serve our community as effectively as possible. **INFORMATION ONLY, NO ACTION NEEDED.** 

### GOOD OF THE ORDER

Commissioners shared information they collected at the WFCA Region 9 meeting in Mason County. One session, Golden Leadership, was presented by Ryan Sperling. Another offered a new concept in building planning – Progressive Building vs. Conventional Building presented by Becky Blankenship. The focus is determining the budget available first, then determining what it will afford rather than the conventional planning process of determining what is needed, how much it will cost and eventually trimming it down to fit the available budget. Numerous companies offer this budgeting model and the Commissioners wanted Ms. Blankenship to present the concept to Staff. A date for the presentation will be determined.

Commissioners are interested in attending two seminars, one offered at the Clearwater Casino on April 30<sup>th</sup> and the other offered in Chelan on June 4<sup>th</sup>. Both center on Leadership and Personnel Issues. Lori is working with them to get their Education Requests entered via the new form on Google Forms.

Chief Andrews shared that he had received a request from Local 2933 to postpone the Anders' appeal hearing with the Commissioners scheduled for March 22<sup>nd</sup>, 2022.
