REGULAR BUSINESS

Chief's Report – Chief Andrews submitted his report:

- Directive 2021-09 COVID 19 Precautions for unvaccinated members.
- The Fire District has been included in the composition of the Jamestown Healing Campus Advisory Committee to help develop contingency plans for impacts to public services.
- The District's attorneys have found an independent investigator that will be able to complete at least one, if not both of the pending misconduct investigations. Once the investigator is secured, Chief Andrews will contact those District members involved in the investigation.
- The District has spent an enormous amount time during the last month, along with the District's attorney, on a large discovery production request. Emails and text messages involving 16 District members over the last two years were retrieved, reviewed and cataloged.

Agenda Bill 3: Karma Cannabis – Assistant Chief Orr shared concerns Staff have about the proposed large expansion of the growing and production facilities of Karma Cannabis in Carlsborg Industrial Park. AC Orr has drafted a letter to the Clallam County Community Development Director asking for guidance from a third party who is well versed in the code requirements. The safety of the facility, the public and first responders is priority. Commissioner Chinn moved and Commissioner Miano seconded to approve AC Orr sending the letter as presented to the Clallam County Community Development Director. MOTION CARRIED.
