Commissioner Chinn moved and Commissioner Miano seconded approving the payment of 2021-Q2 Volunteer Response Reimbursement totaling \$39,655.00 on July 25th, 2021. **MOTION CARRIED.**

Agenda Bill 2: Amended Complaint by S. Anders – Chief Andrews reported that plaintiff Steve Anders has amended his defamation complaint filed against Kolby Konopaski to include "Intentional Infliction of Emotional Distress". On June 10th, 2021 the District received a letter from Enduris outlining the "Employment Practices Liability", what Liability Coverage the District has and what court decisions wouldn't be covered. **INFORMATION ONLY, NO ACTION REQUESTED.**

Agenda Bill 3: Reorganization Plan: Chief Andrews presented the draft of the District Reorganization Plan staff has been working on. He requested that the Board approve the Organizational Structure as presented along with the first five steps to begin executing the plan. After discussion, Commissioner Miano moved and Commissioner Chinn seconded approving the Reorganization Plan and authorizing Chief Andrews to execute steps 1-5. Commissioner Gawley opposed. **MOTION CARRIED.**
