RESOLUTION NO. 2022 - 01

AUTHORIZATION for COMMISSIONER JEFFREY C. NICHOLAS to SERVE as a VOLUNTEER FIRE FIGHTER

BACKGROUND:

In accordance with RCW 52.14.010(3) titled *Number - Qualifications - Insurance - Compensation and expenses - Service as volunteer fire fighter* . section 3, second and third sentences, which state: "The board may, by resolution adopted by unanimous vote, authorize any of its members to serve as volunteer firefighters without compensation. A commissioner actually serving as a volunteer firefighter may enjoy the rights and benefits of a volunteer firefighter."

And based on traditional action of the Board of Commissioners, the Clallam County Fire Protection District No. 3 Board of Commissioners has adopted such resolutions on a case-by-case basis, specifically naming the fire commissioner who is authorized to serve as a volunteer firefighter;

RESOLUTION:

NOW, THEREFORE BE IT RESOLVED by the Board of Commissioners of Clallam County Fire Protection District No. 3 by unanimous vote, that Commissioner Jeffrey C. Nicholas is authorized to serve as a Volunteer Fire Fighter;

AND, BE IT FURTHER RESOLVED by the Board of Commissioners of Clallam County Fire Protection District No. 3 that this authorization entitles Commissioner Nicholas to the same benefits provided to all volunteers with the exception that he is not entitled to the commissioner per diem for time spent in the capacity of serving as a volunteer.
