AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of Clallam County Fire Protection District No. 3 from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Compliance with annual report filing requirements
- Financial condition ratios and financial sustainability
- Ambulance transport billings – monitoring procedures over third-party biller
- Accounts payable disbursements - approval process
- Supplies inventory – safeguards over inventory and process for purchase and distribution
- Leave balances – tracking and monitoring procedures, shared leave and leave buy-backs
- Surplus – approval process and disposal methods
- Participation in other organizations

INFORMATION ABOUT THE DISTRICT

Clallam County Fire Protection District No. 3 was established in 1948 to provide fire protection and prevention services to the citizens of Sequim and the surrounding area. The District operates seven fire stations, three fully staffed, to cover its service area from the Clallam-Jefferson County line to the Deer Park area east of Port Angeles.

An elected, three-member Board of Commissioners governs the District. The Board appoints a Fire Chief to oversee the District's daily operations as well as its 50 employees and approximately 65 volunteers. The District is funded primarily through property taxes, and had an operating budget of approximately \$8.3 million for 2016 and \$8.1 million for 2017.
